**PLEASE TAKE NOTICE** that any qualified elector of Clinton County who is not already registered, may register to vote at the office of the Township or City Clerk; the office of the appropriate County Clerk; a Secretary of State branch office, or other designated state agency. The last day to register in any manner other than in-person with the local clerk is **Monday, October 21, 2024**. After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the following:
